## Proposed Enrolment Scheme Description

**Effective from January 2021**

The guidelines for development and operation of enrolment schemes are issued under section 11G (3) of the Education Act 1989 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

### Home Zone

**All students who live within the home zone described below (and shown on the attached map) shall be eligible to enrol at the school.**

The boundary begins at the intersection of the railway with Taka Street (odd address numbers 19 to 67 included) and travels east to the roundabout of Taka Street, Takanini School Road and Kauri Heart Avenue. Turn left onto Takanini School Road (excluded from zone) and travel north. At the Takanini School Road/Airfield Road intersection turn right and travel east along Airfield Road (odd address numbers from 1 to 219) until it intersects with Mill Road.

Travel south along Mill Road (odd address numbers from 505 to 539) and at 119 Cosgrave Road travel south east along country until it intersects with Old Wairoa Road then travel north east to Papakura-Clevedon Road (excluding 879 and below) until you meet 972 Papakura-Clevedon Road (included) then travel south across country to include Keri Vista Rise, Kokako Rise, Crestview Rise encompassing all the streets in this development.

From the intersection of Keri Vista Rise and Duckworth Road travel east along Settlement Road that transitions into Red Hill Road, travelling south across country and meeting with Hunua Road (272 and below); travel west until after 151 Hunua Road travelling south along country until meeting Ponga Road. Travel west along Ponga Road and south of Sutton Road to the Salesyard entrance. Cross country to Coulthard Terrace and travel north along Great South Road to intersect with Wood Street and ending at the Railway track.

## Out of Zone Enrolments

Each year the Board of Trustees will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The Board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolments will be processed in the following order of priority:

- **First Priority:** *not applicable at this school because the school does not run a special programme approved by the Secretary for Education.*
- **Second Priority:** will be given to applicants who are siblings of current students.
- **Third Priority:** will be given to applicants who are siblings of former students.
- **Fourth Priority:** will be given to any applicant who is a child of a former student of the school.
- **Fifth Priority:** will be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school.
- **Sixth Priority:** will be given to all other applicants.

If there are more applicants in the second, third, fourth or fifth priority groups than there are places available, Selection within the priority group will be by ballot conducted in accordance with instructions by the Secretary. Under Section 11G (1) on the Education Act 1989. Parents will be informed of the date of any ballot by notice in a daily or community newspaper circulating in the area served by the school.

**Applicants seeking second or third priority status may be required to give proof of a sibling relationship.**
